THE PERSONAL DATA THAT ZEBRA COLLECTS

We collect various categories of personal data as described in the Zebra Privacy Statement and process it for the purposes described therein.

Some of the personal data is provided directly by you, such as when you create a Zebra account, make a request on the Site, attend an event or meeting, or contact Zebra for support or to perform other services. Zebra receives some personal data by recording how users interact with Zebra products and services, e.g., by using technologies such as cookies, by receiving error reports, usage data or location data from software running on Zebra products, or from utilizing Zebra services. To the extent permitted by law, Zebra may also collect personal data about you from third parties, including Zebra's third-party partners and suppliers, or from public sources (e.g., commercial registers, the media or the Internet). Categories of personal data that we receive about you from third parties include, in particular, contact data (e.g., information from public registers), contractual data (e.g., credit information), lead data (from marketing agencies) and other data (e.g., information in connection with administrative and legal proceedings).

DISCLOSURE OF PERSONAL DATA

For the purposes set forth in the Zebra Privacy Statement, we may share your personal data with third parties, in

particular the recipients mentioned in the Zebra Privacy Statement.

TRANSFER OF PERSONAL DATA ABROAD

As mentioned above, we may disclose your personal data to third parties. These third parties may be located outside

Switzerland, the United Kingdom ("UK") and the European Economic Area ("EEA"), or may process your data outside these areas, in principle in any country in the world. These countries may not have laws that protect your personal

data to the same extent as in Switzerland, the UK or the EEA. If we transfer your personal data to such a country, we

will ensure the protection of your personal data in an appropriate manner.

One way to ensure adequate data protection is, e.g., to enter into data transfer agreements with the recipients of

your personal data in third countries that ensure the required level of data protection. This includes agreements that

have been approved, issued, or recognized by the European Commission and the Swiss Federal Data Protection and

Information Commissioner, known as standard contractual clauses. Please note that such contractual arrangements

can partially compensate for weaker or missing statutory protection, but cannot completely eliminate all risks (e.g.,

government access abroad). Data may also be transferred to countries without adequate protection in exceptional

cases, e.g., in connection with legal proceedings abroad, if transfer is necessary for the performance of a contract, or

if consent is granted.

RETENTION OF PERSONAL DATA

We process your data for as long as our processing purposes, the legal retention periods and our legitimate interests

in documentation and keeping evidence require it or storage is a technical requirement (e.g., in case of backups or

document management system).

This Swiss Privacy Statement is not part of a contract with you. We may change this Swiss Privacy Statement at any

time. The version published on the Site is the current version.
